PHOTOGRAPHER/ VIDEOGRAPHER MEMBERSHIP AGREEMENT

We ask that you follow a few guidelines that will allow us to maintain the Park for all visitors and future patrons.

Photography Pass Information & Guidelines

- Use of the Park for photography is open to the public during regular Park hours. Photography is not allowed after hours, on days the Park is closed, or during specific special events.
- If a photographer or client wishes to research the Park grounds, prior to the photography session, they are required to pay general admission fees or purchase a Photography Membership.
- Heritage Hill State Historical Park is a public facility and privacy cannot be guaranteed. Areas in the Park cannot be reserved for the exclusive use of any group.
- Reservations are not required for posed photography sessions such as family portraits, engagement photos, senior photos, maternity, quinceañera or the like.
- Reservations are required for wedding photo sessions and group (20 people or more) photo sessions and must be made at least two weeks in advance.
- At no time may anything be suspended or attached to any walls or structures throughout the Park.
- Vehicles are not allowed within park grounds
- Personal belongings may not block pathways, especially when photographing groups.
- Drone flying is strictly prohibited regardless of licensing. Heritage Hill State Historical Park is located on Wisconsin DNR property.
- Heritage Hill State Historical Park is not responsible for any personal property. Valuables should not be left unattended. This includes inside any building or structure on the grounds. The photographer or videographer is responsible for all damage incurred during the reservation period.
- **INDEMNIFICATION:** Renter agrees to indemnify and hold harmless Heritage Hill Corporation, Heritage Hill Foundation, their boards, officers, agents, and employees (hereinafter “Indemnitees”) from any claims, losses, costs, damages, or expenses, including reasonable attorney’s fees, that directly result from (i) the use of the premises by the Renter, Renter’s guests, invitees, or any vendors hired by the Renter for the event, or (ii) any breach or failure by the Renter to comply with the specific requirements and provisions of this agreement. This indemnity covers claims arising from the negligent acts or omissions of the Renter, Renter’s guests, invitees, or any vendors hired by the Renter for the event, but does not extend to claims resulting solely from the negligence or willful misconduct of the Indemnitees
